Roll Call

Approval of the Minutes:

Executive Director's Update

Michael Nix provided updates on the FY2021 911 fee amounts and GECA funds. The NG911 Readiness Assessment was conducted by Mission Critical Partners and Nicola Tidey presented

their findings. The State of Georgia is currently in a foundational stage for NG911. There will be a NG911 Education Workshop next week on December 15, 2020 to provide an update for public safety communications leaders. Natalie Lee with the Geospatial Information Office (GIO) provided a progress report for the GIS component of NG911. GPSTC staff is continuing to develop training for the 911 Directors Academy. Also, finalizing contracts for curriculum development of three NG911 online courses. GECA staff has met with four major providers regarding their solutions for NG911 planning. Also, staff has had discussions with Alabama, California, and North Carolina about their GIS solutions. Michael provided a COVID-19 and GECA update. GECA has been working closely with the Georgia Department of Public Health to ensure that 911 personnel are included in the Phase 1B vaccine guidance. Michael Nix provided an update on the Strategic Plan.





History and Background


Georgia Emergency Communications Authority (GECA) hired MCP to understand the State's readiness to transition to NG911. MCP will:


- Produce an overall readiness gap analysis for NG911 deployment
- Deliver Model for Advancing Public Safety (MAPS) SM assessment findings
- Create an executable plan for procurement for ESInet and NGCS




What is a MAPS assessment?

- A detailed capability assessment across multiple functional areas to assess a state's readiness for NG911
- Interviews using customized questions
- A report identifying gaps and detailed recommendations to close gaps
- Establishes a metric to measure progress against
- Identifies short-term opportunities to focus on while building a long-term vision







Challenges and Implications

- Funding
 - The current fee collected barely covers legacy 911 costs/operations
- Technology and Cybersecurity
 - Diverse technology and equipment in use; will require more effort to piece together in NG environment
 - PSAPs vulnerable to cybersecurity attacks
- Planning and Communications
 - ECC community identified this as a challenge

- Political, Statutory, and Regulatory Implications
 - Legislation will need to be updated to include a new funding model
- Training
 - Georgia has a very robust training program but lacks local training personnel
- GIS
 - No statewide standards exist

Next Steps

- · Write the technical requirements for ESInet and NGCS request for proposal
- · Address funding legislation
- Develop a cooperative procurement vehicle for PSAPs to be able to purchase CHE equipment compatible with the ESInet and NGCS solution
- · Identify members for an RFP review committee





Preliminary Do you have a GIS file? Observations We are not starting with nothing! But we have a long way to go in many areas to be ready for an ESInet deployment. Initial Insights (we are still cleaning): Confirmation of education need and Disconnect between communities (lack of coordination) Need for development/adoption and implementation of standards at the state level We are using a 100% stacked column chart to show the overall % of respondents who answer positively or negatively.







- GPSTC staff is continuing to develop the 911 Directors Academy curriculum.
- Aiming for a pilot course of the 911 Directors Academy in Q1 of 2021.
- Finalizing contracts for curriculum development of three online courses
 - Introduction to NG911
 - Cybersecurity: Protecting 911 Inside and Out
 - Emotional Wellness in a NG911 Environment
- Scheduling courses for 2021 that will be presented regionally with no registration fees for 911 centers.
 - CTO and Supervision first



NG911 Planning

- GECA staff has met with four of the major ESInet/NGCS providers for preliminary discussions regarding their solutions.
 - AT&T
 - Comtech
 - INdigital
 - Motorola
- GECA staff has also had discussions with other states regarding their NG911 and GIS solutions.
 - Alabama
 - California
 - North Carolina

COVID-19 and GECA

- 187 daily reports to 911 centers with COVID-positive address information since mid-April.
- Working with DPH to ensure that 911 personnel are included in Phase 1b vaccine guidance for vaccine distribution due to their support of field responders as well as the close proximity in a 911 center and challenges faced trying to social distance.

Strategic Plan Update: 911

- Basic to Enhanced
 - Georgia has 3 counties without E-911.
 - Field staff continues to make progress in each of these counties.
 - At least 1 will become Enhanced in 2021.
- Telephone CPR (T-CPR)
 - GECA Board adopted T-CPR Taskforce recommendations in March.
 - Amy Ramsey is going to be staff lead on this project and is currently identifying and evaluating existing commercial T-CPR protocols.



- Partnership with Office of Public Safety Support (OPSS)
 - Pamela Waters is staff lead for this project and will be working with the OPSS staff in determining how 911 personnel are include in this project and how to get 911 personnel credentialed as an OPSS-certified peer counselor.

Strategic Plan Update: Interoperability

- Promote the use of tactical channels/NIFOG/GAFOG
 - Currently updating the GAFOG and creating an e-FOG for easier accessibility
- · Increase private sector relationships
 - Continue to meet frequently with two largest public safety radio system providers in the state (Motorola/Harris)
- Conduct Mobile Communications Vehicle exercises
 - Conducted Area 6 (NW Georgia) MCV exercise in November



- Communications Unit (COMU)
 - COMU Working Group has approved a draft, updated COMU plan and will be presented to the ESF-2 committee and then GECA Board for approval and adoption.
- Telecommunicator Emergency Response Taskforce (TERT)
 - 90 active members from 45 agencies
 - (#1 in the country!!)
 - 3 members from Baldwin County, Georgia responded to Baldwin County, Alabama for Hurricane Sally in October.

Strategic Plan Update: Alerts and Warning

- Emergency Alert System (EAS)
- GECA staff maintains relationships with the Georgia Association of Broadcasters and assists GEMA/HS staff with the required weekly and monthly tests of the EAS.
- Integrated Public Alerts and Warnings (IPAWS)
 - The State Warning Officer continues to assist counties with their IPAWS plans and applications.
 - GECA is processing 2-3 applications per month.

Strategic Plan Update: Public Safety Broadband

Monitor FirstNet activities

- Receive weekly updates from FirstNet/AT&T regarding new towers that have come online with Band 14 (public safety only spectrum) coverage
- Roughly 40 towers per quarter are being added across the state
- Mission critical push-to-talk (MCPTT)
 - GECA Field Staff have demoed 3 types of radios with LTE components and will continue to work

2021 911 Legislation

- Funding
 - Increase 911 charge?
 - Find alternate funding streams?
 - Budget appropriations?
- Governance
 - Legislation needs to ensure that GECA has the abilities to provide meaningful oversight of the NG911 implementation.
- Training
 - What is the appropriate amount of continuing educations hours for 911 personnel?



2021 911 Legislation

- Looking at the possibility of including communications officers in the Peace Officers' Annuity and Benefit (POAB) Fund
- Retirement bills must be introduced in the first year of a biennium (odd numbered years)
- After session, an actuary will be completed to determine the amount needed to continue the funds solvency if communications officers are added.
