## Service Supplier Registration Information

Georgia Code Section 46-5-122 defines "Service Supplier" as a person or entity who provides telephone service to a telephone subscriber; and defines "Telephone Service" as any method by which a 9-1-1 emergency call is delivered to a public safety answering point. The term "telephone service" includes local exchange telephone service or other telephone communication service, wireless service, prepaid wireless service, mobile telecommunications service, computer service, Voice over Internet Protocol service, or any technology that delivers or is required by law to deliver a call to a public safety answering point; and defines "Telephone Subscriber" as a person or entity to whom telephone service, either residential or commercial, is provided. When the same person, business, or organization has several telephone access lines, each exchange access facility shall constitute a separate subscription. When the same person, business, or organization has several wireless telephones, each wireless telecommunications connection shall constitute a separate connection.

Georgia Code Section 46-5-124.1 requires telephone service suppliers doing business in the State of Georgia to register with the Georgia Emergency Management Agency. In addition, after initial registration, telephone service suppliers must update their information twice yearly, by January 10<sup>th</sup> and July 10<sup>th</sup>. Failure to re-register could make a telephone service supplier ineligible for cost recovery funds.

The specified registration information is outlined in Georgia Code Section 46-5-124.1, subsection (a), which is printed below for your convenience.

- (a) Any service supplier doing business in Georgia shall register the following information with the director:
  - (8) The name, address, and telephone number of the representative of the service supplier to whom the resolution adopted pursuant to Code Section 46-5-133 or other notification of intent to provide automatic number identification or automatic location identification, or both, of a telephone service connection should be submitted;
  - (9) The name, address, and telephone number of the representative of the service supplier with whom a local government must coordinate to implement automatic number identification or automatic location identification, or both, of a telephone service connection;
  - (10) The counties in Georgia in which the service supplier is authorized to provide telephone service at the time the filing is made; and
  - (11) Every corporate name under which the service supplier is authorized to provide telephone service in Georgia.
